

Emulsion SS-1:- Emulsion SS 1 is specially designed oil based Bitumen Emulsion with low viscosity, extended setting time and stability with cement that makes it an ideal product for Prime Coat application.

Emulsion Cold Mix:- Emulsion Cold Mix is specially designed oil based Bitumen Emulsion with low viscosity, extended setting time and stability with cement that makes it an ideal product for Prime Coat application.

Penetration Grade Bitumen

Penetration Grade Bitumen is a standard Bitumen usually used as a Paving Grade Bitumen essential for road construction and for the production of asphalt pavements with superior properties, and it's very important once it bounds the aggregates and creates a unique cohesion and stability to the bituminous mix.

This unique temperature/viscosity relationship is important when determining the performance parameters such as the adhesion, rheology, durability and application temperatures of bitumen.

Viscosity Grade Bitumen

Viscosity Grade Bitumen shall be prepared by the distillation of suitable crude, petroleum oil without subsequent blending with other grades. The material shall be homogenous and shall not foam when heated to 175°C. No Mineral matter other than naturally contained in the material shall be present.

Paving Bitumen covers physical and chemical requirement for use in Roads, Airfields and allied construction. Also some of the grades may be used for industrial purpose. This material used in Construction and maintenance of Roadways, Saturant for roofing felt, electrical cables for manufacturing Bitumen Emulsion etc.
